SAFETY IS IN YOUR HANDS. EVERY DIG. EVERY TIME.

On average, 65 damages to underground utility facilities occur each day in Florida by someone who failed to follow the safe digging process outlined in the Underground Facility Damage Prevention and Safety Act, Chapter 556, F.S. That's 23,645 times per year in 2022 that excavation activity damaged buried power, gas, internet, water and other utility lines across the state.

Fire personnel as well as code, local and state law enforcement have likely responded to incidents like these where crews or homeowners inadvertently damaged an underground line causing a service outage, evacuations, road closures, boil water notices, and more.

Preventing underground utility damage and enforcing the law is a shared responsibility among everyone working in and tied to the industry – from excavators, utilities and line locators to the fire chiefs, local or state law enforcement officers, government code inspectors and code enforcement officers.

Today, as Florida continues to rank among the top states in the U.S. for population growth and construction activity – coupled with billions of dollars of new federal infrastructure and other projects being infused into the state – preventing damage to underground utilities and enforcing our safe digging law has never been more important.

Sunshine 811's Role & Expanded Efforts

Sunshine 811's role in the enforcement process centers on education, awareness, outreach and relationship building. In 2022 and through this year, our organization has greatly expanded those efforts in the following ways:

- We became active members of enforcement and excavator associations, including: the Florida Association of Code Enforcement (FACE), the Florida Police Chiefs Association (FPCA), the Florida Sheriffs Association (FSA) and Associated Builders & Contractors of Florida (ABC).
- We participated and exhibited at numerous trade shows of these and other groups, interacting directly with their members and building greater awareness of the 811 process and law.

Sunshine 811's Role & Expanded Efforts continued

- We placed a series of strategic publication advertisements and web banner ads with the previously mentioned associations that promoted the enforcement component of Florida's safe digging law.
- We secured expert testimonials from enforcement officials, including the office of JoAnne Rice, MPA, CFO, Director, Florida Division of State Fire Marshal, on "working together to keep our state safe and enforcing safe digging practices." Those testimonials were promoted on social media, in presentations and in advertising.
- We placed bylined articles focused on damage prevention and enforcing the law in the publications of FACE and Florida Fire Service Magazine.
- We developed new, compelling collateral materials featuring the stages of a citation, safe digging toolkits and more.
- Included a short, narrated presentation on Chapter 556, FS., violations on our website, sunshine811.com.
- Assisted the Office of the State Fire Marshal and the Florida Public Service Commission in completing the annual PHMSA State Damage Prevention Law Enforcement Program Evaluation for Florida.
- Our safety and education liaisons delivered excavator and enforcement-focused presentations throughout the state and in conjunction with Paradigm. In addition, our liaisons met one-on-one with dozens of code and enforcement officials to increase awareness of the 811 process and law.
- Presented *Enforcing Chapter 556* to a virtual audience through the Florida Sheriff's Association. The presentation was recorded and added into the Sheriff's library for officers to view.

Beyond Enforcement Awareness


In addition to enforcement awareness, Sunshine 811 executed a number of public awareness campaigns to build awareness of the safe digging process and prevent damages to underground utilities.

- Throughout the year, we reached out to our member utility companies, excavators, cities and counties to inform and update them on issues and to recommend problem-solves regarding damage prevention.
- Deployed strategic emails to a database of approximately 52,000 excavators and 1,000 members to reinforce the 811 process, excavator/member roles in improving the process, and overall shared goals.
- Partnered with the Florida Nursery Growers & Landscaping Association (FNGLA) and the Florida Chapter of the American Fence Association to increase awareness of damages being caused by fencing and landscaping which, combined, are the greatest contributors of utility damages as identified and reported to Florida's Virtual Private Damage Information Reporting Tool (DIRT) in the state.
- Deployed an email takeover to 2,500 members of the Florida Nursery Growers & Landscaping Association (FNGLA) to reinforce the 811 process, their role in improving the process, and specific tips to employ. A second campaign with the download, *10 Tips from Sunshine 811*, was sent to 11,000 members (44% open rate) of the FNGLA.
- Updated three "plug and play" toolkits for Florida's stakeholders to download and use to educate their customers and the public on 811 before digging: After the Storm, Safe Digging Month and 811 Day. Each toolkit contains safe digging resources (press releases, op-eds, newsletter story, social media messages, mini-infographics and handouts) needed for Florida's stakeholders to get the word out to their customers, colleagues and partners.
- Reinstated our highly successful After the Call email campaign a series of three emails sent at specific intervals throughout the 30-day ticket life to provide immediate education on the next steps within the process. It regularly sees higher-than-average open rates.
- Created new video for 811 Day deliveries to news desks and two anchors at radio and television stations (CBS, ABC, NBC, Spectrum, FOX affiliate, and three iHeart stations) in Central Florida. Deliveries included a cake, two to three plants, notecard and jump drive with assets from 811 Day Toolkit.
- Created a compelling collateral piece featuring damage-prevention tips for fencing and landscaping companies that we shared in an email campaign to 1,400 Florida-based fencing and landscaping companies and distributed at The Landscape Show.
- Deployed a statewide media pitching campaign, securing 20 media placements of our news story.
- Partnered with member utility companies JEA and TECO Peoples Gas to run billboards during Safe digging Month in the Orlando, Miami and Jacksonville areas.
- Developed a legislative awareness collateral piece and emailed to Senate & House leadership, Senate Committee on Regulated Industries and the House Committee on Energy, Communication & Cybersecurity. Efforts resulted in several meetings between key legislators and our lobbyist.

Beyond Enforcement Awareness continued

In addition to the activities on the previous page, Sunshine 811 conducted a multi-layered spring awareness campaign. It combined a mix of general awareness advertising and more targeted education-driving messages.

- Radio and Streaming advertising to build broad awareness among professional excavators on top radio stations and Spotify streaming.
- Digital display banners to reach new and existing 811 users with educational prospecting ads and ticket-focused retargeting ads.
- Google Performance Max to deliver digital ads across all of Google's ad platforms (search, banners and YouTube). Ads targeted English- and Spanish–speaking contractors (focusing on light contractors, landscapers and fence installers) and homeowners.
- Outdoor billboards placed in strategic locations to reach excavators who spend more time on the road than the average commuter.



On the Horizon

We will continue to promote fair and effective enforcement throughout Florida through education, relationship building and creating awareness. All Sunshine 811 initiatives – whether video, print, online, social or face-to-face gatherings – are designed to educate all damage prevention stakeholders to facilitate understanding and compliance with Chapter 556, F.S.

We will continue focusing our awareness and educational efforts on high-growth areas throughout the state and working with key enforcement decision makers within Florida's cities and counties. Additionally, we will sponsor and promote regional Damage Prevention Councils throughout the state and a series of educational webinars for those in the code and law enforcement communities, both providing a forum for discussing issues and sharing solutions to construction- and enforcement-related challenges.

Recommendations

- **1. Respectfully request the Governor to officially proclaim April 2024 as Safe Digging Month** in Florida, to increase public awareness of the need to call Sunshine 811 before digging and to dig safely to prevent utility service interruptions, environmental damages, and personal injuries.
- **2.** Seek sponsorship and support for the following amendments to Chapter 556, Florida Statutes, in the 2024 Legislative Session:
 - a. Changing the excavator notification and member response timeframe from 2 to 3 full business days for excavation or demolition on dry land. The notification and response timeframe for underwater excavation or demolition will remain at 10 full business days.
 - b. Including failure of the excavator to notify the pipeline operator of the planned start date and time before beginning excavation near a hazardous material transmission pipeline as a citable violation of Chapter 556, Florida Statutes, subject to an enhanced civil penalty of \$2,500.
- **3. Partner and work collaboratively** with the Office of the State Fire Marshal and the Florida Public Service Commission on the PHMSA State Damage Prevention Law Enforcement Program Evaluation for Florida and other educational initiatives.
- **4. Conduct a targeted awareness program** with key enforcement decision makers within Florida's cities and counties to encourage fair and effective enforcement of Chapter 556, Florida Statutes.
- **5. Continue building upon the partnerships** Sunshine 811 built with enforcement and fire associations by:
 - a. Launching a quarterly webinar where enforcement communities throughout the state can get education on Chapter 556, Florida Statutes, and ask questions of their peers;
 - b. Participating in association trade shows and/or conferences; and
 - c. Submitting articles to enforcement publications.

2022 Excavator Survey CONDUCTED BY MGH

Sunshine Excavator, Member & Homeowner Research Completed by MGH UPDATED June 12, 2023	 Objectives To gauge homeowner awareness of and experience with the 811 process and to better understand excavator and member awareness and understanding of utility response and low impact markings. Online survey of Florida homeowners, utility members, and professional excavators working in the state of Florida. Respondents were invited to participate in the survey from a list of contacts provided by Sunshine 811. We collected a total of 2, 575 survey responses. 1,503 homeowner, 316 member and 753 excavator
Exactix still causes some confusion among homeowners While overall satisfaction with directions on how to create a ticket and the overall process of submitting tickets online has increased slightly since measured last year (+6% and +5%, respectively), there is still confusion among some homeowners. As a result, many end up calling in their locate request because they are not able to complete the process online. Main concerns include technical verbiage, mapping issues, addresses not found in the system and issues finding the right place to submit locate requests. Several homeowners also brought up that the online process is not	Many homeowners are also unsure of the utility response process Only 47% of homeowners were very familiar with their responsibility to check that all utilities have responded to their locate request. There is also some confusion among homeowners about the process of marking their underground utility lines. Several homeowners stated that utilities were never marked in response to their locate request. Others were unaware that not all utilities would be marked at the same time by the same person, and were surprised to have several locators show up at different times.
Mobile friendly. Locate and excavation delays are frequent Only 24% of excavators say that excavation frequently starts exactly two business days after the locate request has been submitted. 19% say they frequently experience delays because not all utility members have responded to the ticket. An additional 39% say it happens sometimes. 59% of members say they don't have enough locate staff at least some of the time. 57% of excavators say that at least sometimes.	Locate requests are often missing accurate information and mapping While members are very satisfied with the 811 process and getting requests in a timely manner, they are less satisfied with excavators providing accurate mapping and accurate/complete ticket information. Only 66% of excavators say they are very familiar with what specific site information they should include on the ticket and how large of an area it can include. The majority of excavators submit locate requests online, but only 57% of them find the system very easy to use. However, while 71%
57% of excavators say that at least sometimes, not all utilities have been marked when excavation starts, and 51% of members say that excavation has started before they have marked their utilities.	57% of them find the system very easy to use. However, while 71% of Exactix users are aware of the new training, only 48% have viewed it.

2022 Excavator Survey continued

Locate ticket renewals happen frequently

Ticket renewals is big issue causing the delays in excavation and locate markings.

44% of members say they frequently have to re-mark the same dig site because the ticket was renewed. 20% of excavators often experience having to renew a ticket for the same dig site – mainly because they either didn't start or finish excavating before the ticket expired.

32% of members say they frequently have to mark very large areas on the dig site and 38% of excavators say the prefer to always have an active ticket on larger dig site, as they don't always know the exact digging location on a daily basis.

Excavators still need locate tickets before city and council permits are issued

One reason that excavation either doesn't start and is not complete before the locate ticket has expired could be that many need to submit locate requests before getting work permits.

31% of excavators say they are always required to obtain a locate ticket before being issued city or council permits, while an additional 30% say it is sometimes required.

Excavators are unsure of the term low impact marking

Only 20% of excavators say they are very familiar with low impact markings (and additional 30% are somewhat familiar), and there also appears to be some confusion around especially white lining and how large of an area a ticket can cover.

Executive summary recommendations

Increased emphasis on "after the notification" message information to homeowner audience, setting expectations about the locating process.

An all-stakeholder focus on improved usage of the system: better ticket scope from excavators (including usage of white lining) and more timely response from members/locators.

Executive summary recommendations

Use more direct language with excavators when seeking to produce low impact marking. Use terms like "clearly define your work area" and "white line the proposed excavation" to connect with the excavators' actions that result in lower impact marking by facility operators.

Seek common sense changes to municipal/county building code regulations that require a Sunshine 811 ticket before a building permit can be issued. The life of an 811 ticket is much shorter than building permits, so the order should be reversed to prevent excess tickets. Consider researching data points on the number of renewed tickets issued to municipalities/counties over the last year to put a potential price tag on the problem.
